11. If any materials like written/printed chits, mobile, digital diary, electronic instruments, paper are found with the candidate in the examination hall, he/she will be debarred from the examination.
12. Subjects printed in the admission card are based on the data enter by the candidates / Colleges. If any changes such as name correction, subjects, exam center etc. is required then the Principal shall do the corrections and bring the same to the notice of the Registrar (Evaluation) after completion of examination by the principal in person.
